#### 2. Minutes of the last Meeting:

# a) Planning & Conservation Group

In the absence of Cllr. King, Cllr. Wing reported.

The Parish Council's response to the retrospective application for the wooden cabin on land adjacent to the canal and Meadow Lane had been circulated with the report. It is not known when the decision will be made.

Agents for Vodaphone have sent information concerning an application which is to be forthcoming for a mobile phone mast in Jewsons Yard (on Tyning Road). We will await the actual application before making any comment.

#### b) Highways Group

The report had been circulated.

Cllr. Rossiter reported that B.& N.E.S.Council has misunderstood the situation on the Canal. They have no co-ordination on canal issues and refer to boaters as "water travellers".

The response from our M.P. concerning High Hedges has been disappointing.

# b) Highways Group(Cont'd.)

The draft V.P.A. response to the B.& N.E.S. consultation paper on Gypsies, Travellers and Travelling Showpeople, which has been prepared by Dave Batho(Claverton P.C.) and Cllr. Rossiter was circulated with the report. The Chairman, seconded by Cllr. Wing, proposed that we approve this draft response. Agreed.

It was stated that there was unlikely to be any publically owned land in our Parish which could be identified as a suitable site. Much is Green Belt and not eligible.

In the absence of Cllr. Mayo, it was agreed to leave discussion of the Parish Agency Scheme for the maintenance of footpaths to the next meeting.

# c) Leisure & Amenities Group

The report had been circulated.

As nothing had been heard from British Waterways concerning the small hut at the corner of Jubilee Gardens, Cllr. Richards wondered if our Local History Research Group would like to take an interest in it. It could be listed as a "Local Asset" and put in a Local Plan.

Jeff Havvock has been instructed to remove the dead trees on the allotments and to proceed with making a parking area by the Down Lane entrance.

The Clerk reported that he had applied for a grant under the auspices of a Ward Councillors Initative to cover the cost of repairs to the childrens' play area.

The Clerk then said that as we have agreed to change the allotment rental year to begin on 1<sup>st</sup>., January as from 1<sup>st</sup>., January,2013, we need to agree any increase in rent for that year now so that we can give twelve months notice of the increase. The Chairman, seconded by Cllr. Richards, then formally proposed that we increase the rents by 50p. per lug as from 1<sup>st</sup>., January,2013. This was agreed unanimously. **CLERK** 

#### d) Policy & Finance Group

The report had been circulated.

The Chairman said that there was nothing further to add. He then gave advance warning of the deadline for the next Newsletter. This would be Friday, 20<sup>th</sup>.,January, one day after our next meeting.

Cllr.Ardrey had circulated a report on his attendance at a Neighbourhood Planning Protocol Briefing. This is a new aspect of planning associated with the Localism Act which is due to come into force next April. Neighbourhood Plans, though not compulsory, can be formulated by parish councils or by a neighbourhood forum.

He says that aeroplanes and seagulls make more noise than his cockerel. It was agreed that the Clerk would write to Mr. Godfrey(from whom the original letter of complaint came) and suggest that hereports it to the B.& N.E.S.Council's Environmental Health Department.

Finally, the Clerk confirmed that our membership of the Kennet & Avon Canal Trust has been renewed.

# 5. Matters Arising:

The Chairman reminded councillors that we still need to find a "Mission Statement" for the Web-site.

Also, Cllr. Rossiter reminded the Council that we were to consider putting a bus shelter in Holcombe Lane by the shops. However, the Chairman said that the No.4 route is to be upgraded to a Showcase route and it would therefore be best to postpone any decision at present.

The Clerk said that he had not yet written to the owner of the house in The Chestertons whose fir trees are encroaching on to the footpath of the Warminster Road opposite Hantone Hill. He would write as soon as the number of the house was confirmed.
